## Ireland successfully auctions Treasury Bills

The Irish National Treasury Management Agency (NTMA) held an auction of Irish Treasury Bills on Thursday 10 September 2009. One Treasury Bill line was offered in the auction with a maturity of six months and a target issuance range of €800 million to €1 billion.

Total bids were received for €2.7 billion and it was decided to issue a total of €1 billion

The weighted average annual interest rate and bid-to-cover were as follows:

<b>Maturity</b>	<b>Rate</b>	<b>Cover</b>
<b>6 months</b>	<b>0.481%</b>	<b>2.7</b>
