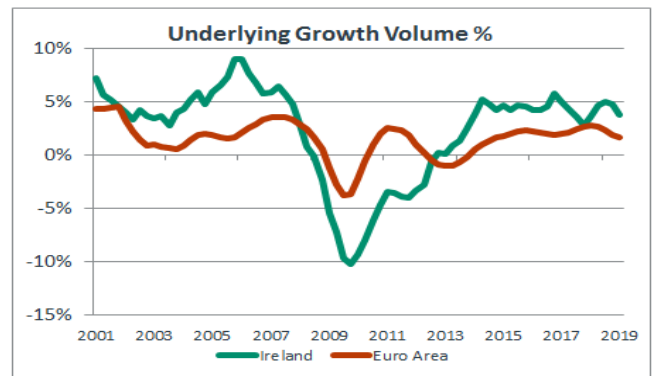

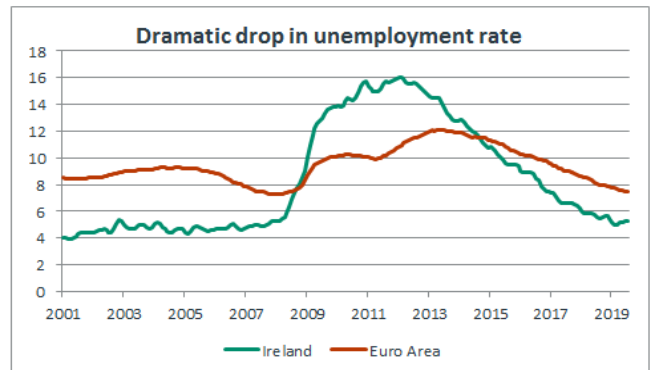

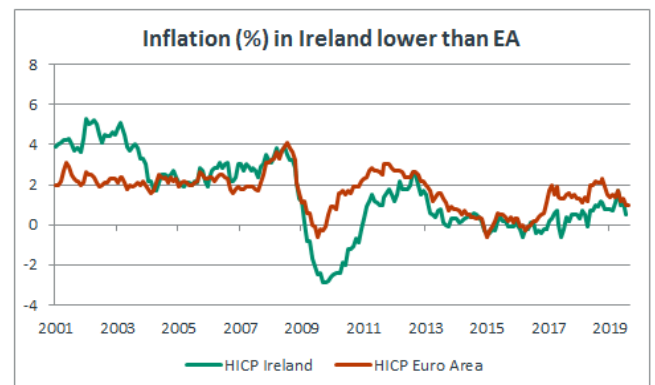
#### Growth above euro area from 2012
