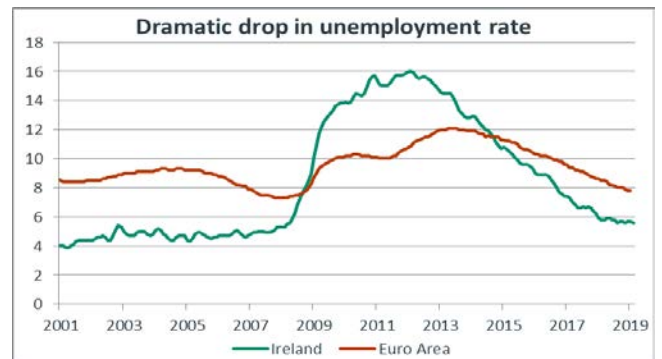

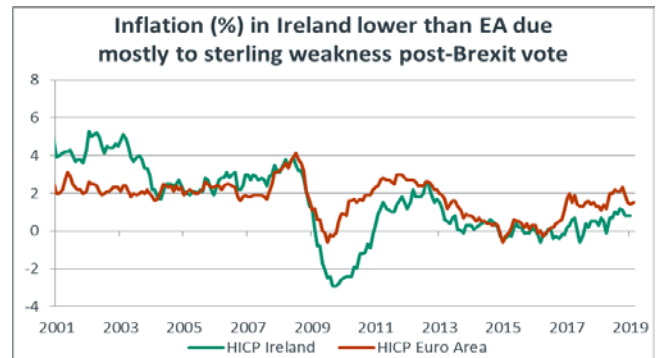
Averaging 5% Growth 2014-2018
